*Cart Rental is \$15.00/player for 18 holes or \$8.50/player for 9 for "NO CART PACKAGE" option. A cart fee shall be paid if using a CLGC Cart or if riding with a private cart owner unless you have the Unlimited Rental Option.

** Junior Membership is for those aged 19 or under as of September 1st. No cart fees are offered with this Membership. Call the Golf Shop for restrictions and a separate Junior Membership Application.

Single Membership-Valid only for the one person listed on the application.

Double Membership- Valid for two players in the immediate family. Could be a husband & wife or the second player could be a child in the family living under the same roof as the adult(s) if the financial responsibility still falls with the adult(s) and the child is still in school. The child would have to be 21 years of age or under as of September 1st of the calendar year of the Membership.

Family Membership- The same as a double, but everyone in the immediate family living under the roof of the adult(s) with financial responsibility still falling with the adult(s) could use the Membership benefits. Again, the children would have to be 21 years of age or under as of September 1st of the calendar year of the Membership.

NOTE: Regardless of Membership category, children in the immediate family 12 years of age and under are not charged as part of the Membership, but have free green fee and cart fee privileges if accompanied by an adult. All kids 13 -17 whose parent(s) have a golf Membership have waived green fee privileges but must pay appropriate cart fees if unaccompanied (unless on the Family Membership or that child is listed as 2nd on the Double Membership).A valid driver's license or learner's permit is required to operate a rental or private cart on golf course property.

Payment Schedule for Quarterly Payment Option

1st Quarter due by: January 31st
 2nd Quarter due by: April 30th
 3rd Quarter due by: July 31st
 4th Quarter due by: October 31st

If you have a new private golf cart, we need to have a "Private Cart Agreement" on file, stating you will abide by our trail rules. You will also need to provide a copy of your homeowners insurance stating your cart is insured. Please note that all Private Carts are REQUIRED to be equipped with sand buckets for divot fill. Please contact Tom at the Golf Shop or Chad in Maintenance about getting these purchased and installed if you do not have them.
